## **Summary**

This investigation determined that the allegations of corruption within Engineering Services that were made by Frank Crupi of Road Surface Recycling Limited (RSR) were not supported by the available evidence.

## **Background**

In August 2021, the City executed Contract ENG21-38 with RSR for resurfacing a portion of the Kingsway. RSR commenced work on June 20, 2023, and paved on June 21, 22, 28, 29, July 4 and 11. After identifying non-conformances within the work completed, the City issued a notice to cease all work on July 11, 2023. On July 13, 2023, the City issued a letter of non-conformance directing RSR to cease work.

On September 22, 2023, Frank Crupi of RSR emailed the media and members of Council alleging corruption within Engineering Services. No evidence supporting these allegations was provided by the complainant with his original submission.

## **Investigation Methodology**

Due to the seriousness of the allegations received, the Auditor General's Office engaged an independent subject matter expert to provide quality control advice for this investigation. Thereafter, the following processes pertaining to the allegations were examined by the Auditor General's Office:

- conflict of interest management processes;
- purchasing and payment processes;
- change order management processes;
- warranty management processes; and
- issue management processes.

## **Allegation and Investigation Results**

At the end of business on December 8, no evidence to support the allegations had been submitted by the complainant despite requests for information from the Auditor General's Office that were made on November 25 and November 27.

The results of our investigation are set out below:
