
### Ward 2 Walden Copper Cliff





**Comment:** This proposed Ward forms a cohesive ward based on demographics and distinct geographic boundaries. The proposed new ward satisfies all four criteria as set out in the terms of reference. It contains the bulk of INCO operations and recognizes the transportation and recreation linkages between the two communities of Copper Cliff and Lively. It is a major recreational area of the City of Greater Sudbury and provides for a good mix of urban and rural uses. It also addresses potential growth in the Mikkola area of Lively.

**Comment:** Though the largest ward in terms of land mass, this proposed Ward satisfies all four criteria. Much of the area to the north and east is sparsely populated, with few permanent residents. Overall, the ward contains several viable urban centres whose population should remain fairly stable over the next decade, while at the same time recognizes possible expansion in serviced areas such as Garson. This Ward contains a good mix of urban and rural uses, including mining, recreation, and transportation (Sudbury Airport).







The core of this Ward is an area of commercial and institutional expansion (Cambrian College). The lower ward population acknowledges that residential infill will continue to take place at a continuous pace, thereby maintaining a stable population while also allowing for potential growth.

**Comment:** This proposed Ward has the highest population variation of the proposed 12 Wards; however, it satisfies all four criteria. This Ward has the highest concentration of residential population in the City and contains well-established institutional uses. The ward presents the most varied economic and social mix in the City. Its neighbourhoods are easily recognizable and clearly defined.


