At the April 11, 2005 meeting of the Greater Sudbury Police Services Board, the Board approved a renewed two year Community Policing Partnerships (CPP) Program Contractual Agreement, effective April 1st, 2005 and expiring March 31st, 2007.

This a tri-party agreement between the Police Services Board, the Ministry and the City of Greater Sudbury wherein the Province cost shares the salary and benefit costs for front line police officers. Currently the Service recovers \$240,000 per year through this grant. The existing agreement expires on March 31, 2005. This new agreement will extend the funding for a further two years to March 31, 2007.

Attached is the April 1, 2005 report presented by the Chief of Police and the Resolution of the Board approving the agreement and requesting the City of Greater Sudbury to enter into the renewal agreement.

RECOMMENDATION:

THAT the Board enters into a renewed two-year Community Policing Partnerships (CPP) Program Contractual Agreement, effective April 1, 2005 to March 31, 2007.

And further, that the Board requests that the City of Greater Sudbury Council also enters the renewed Agreement.

BACKGROUND:

In 1998, the Police Services Board and the then Regional Municipality of Sudbury Council entered into an Agreement with the Ministry of the Solicitor General under the Community Policing Partnerships Program. Pursuant to the terms of the Agreement, five additional front-line police officers were identified for hire, thereby increasing the sworn compliment from 233 to 238.

Subsequently, on June 19, 2000, the Ministry advised that there were forty-nine remaining spaces under this Grant which would be available for Police Services to apply. In response to this, a full staffing analysis was undertaken wherein the need for an additional fifteen front-line police officers was identified. To this end, an application was made requesting an additional fifteen officers under the CPP Grant. In November 2000, the Service was advised that under this Program, Sudbury would be receiving an additional three (3) officers; thereby increasing the authorized strength from 238 to 241 sworn members.

These additional officers are now fully trained and deployed to the front-line patrol function. The program is based on a cost sharing formula, wherein the Province will fund half or up to \$30,000 the annual salary and benefit costs for each officer. Currently, the Service recovers \$240,000 per year through this Grant.

CURRENT SITUATION:

The present Agreement expires March 31, 2005.

The Ministry is requesting that the Board enters a renewed two-year CPP Contractual Agreement for a period of two years effective April 1, 2005 extending to March 31, 2007.

The Board will recall that this is a tri-party agreement between the Police Services Board, the Ministry and the City of Greater Sudbury. In this regard, it is recommended that Council be requested to enter into the renewed Agreement as well.

The Board will also note that this Agreement has no correlation to the current proposal by government to increase the number of police in the province by one thousand (1000) officers. It is interesting to note that the Service has been on record having identified the need for an additional fifteen officers for the last five years.

Dear Chief Davidson:

In keeping with the Ontario government's commitment to place more police officers on our streets, funding will continue to be provided through the **Community Policing Partnerships (CPP) Program** to municipalities across the province. Through this cost-sharing initiative, police services will be able to maintain their increase in front-line presence.

Enclosed, please find a renewed two-year CPP Contractual Agreement for your service, effective April 1, 2005 to March 31, 2007. This Contractual Agreement replaces your existing one, which will expire on March 31, 2005.

In order for your service to continue receiving funding through the Program, you must enter into the enclosed Contractual Agreement with the ministry. This letter forms no part of the Contractual Agreement.

The grant must be used in accordance with the terms and conditions set out in Schedule A and your application, attached as Schedule B. I draw particular attention to sections 2, 6 and 7 in Schedule A. These sections stipulate that:

- The Grant shall be used by the Board and the Municipality solely for the purposes of increasing the complement of front-line, uniformed police officers and for no other purposes; and
- The Board and Municipality shall submit a September 30th interim report and a March 15th annual report in each of the ministry's fiscal years, as set out in Schedule C.

Also, please note that the grantee shall provide proof of its general liability insurance (\$5 million) indemnifying the Ministry of Community Safety and Correctional Services. Additionally, Municipal Council must put in place a municipal by-law or resolution authorizing the municipality to enter into this Agreement with the ministry.

The grant will be paid in arrears after submission of satisfactory CPP Program interim and annual reports. In order to claim any reimbursement, this Contractual Agreement, must be executed between the ministry and your municipality and police services board.

Enclosed are three copies of the Contractual Agreement. Please arrange to have all three copies signed by the appropriate municipal council and police services board representatives and return all three copies as soon as possible to:
