

# Notice of Nomination for Office of District School Board Trustee

Municipal Elections Act, 1996 (s.32)

The Municipal Elections Act, 1996 permits the filing of nomination papers on any weekday, leading up to Nomination Day, during an election year.

For the October 2010 municipal election, Nomination Day is Friday, September 10, 2010.

Nomination papers from candidates seeking the Office of School Board Trustee are now being accepted, based on existing geographic areas. Any choice of geographic area will be subject to change pending the release of the applicable regulation by the Minister of Education, the reporting of the electoral population data for each school board by the Municipal Property Assessment Corporation, and the completion of the trustee determination and distribution by the applicable Board.

Upon completion of the process for trustee determination and distribution, should any changes result in the geographic area, candidates will be required to file another nomination paper for the office of Trustee, designating the relevant geographic area in which they wish to be a candidate. Where a new nomination paper is not filed within a fixed period of time, the previous nomination paper will be deemed to have been withdrawn.

## The Nomination Process

Notice is hereby given that candidates may be nominated for the offices of School Board Trustee by filing the prescribed form in the City Clerk's Office of the City of Greater Sudbury. A nomination

must contain original signatures and may be filed in person or by an agent, between 8:30 a.m. and 4:30 p.m. from Monday, January 4, 2010 to Thursday, September 9, 2010; and between 9:00 a.m. and 2:00 p.m. on Friday, September 10, 2010, (Nomination Day).

The term of office is December 1, 2010 to November 30, 2014.

## The Nomination form shall:

- be in the prescribed Form 1 (Nomination Paper);
- be accompanied by a Declaration of Qualification;
- be signed by the person being nominated; and
- be accompanied by the prescribed nomination filing fee (\$100)

The \$100 nomination fee is payable to the City of Greater Sudbury by cash, certified cheque or money order.

Until you have filed your nomination (Form 1) with the Returning Officer for the City of Greater Sudbury, your campaign organization is not entitled to raise money nor incur any expenses. Also, you cannot spend any personal funds on your campaign before filing your nomination (Form 1).
