

1. Introduction

This annual report is provided in accordance with the *Clean Water Act (the Act), 2006, Part IV, s. 81*. It outlines the activities undertaken in the 2022 calendar year by the City of Greater Sudbury's Risk Management Official.

2. Risk Management Officials and Inspectors

2.1 Appointment by Council

The City of Greater Sudbury's Appointment of Officials By-law 2019-193, Schedule B, Part 1 appoints statutory roles by positions, as per the *Clean Water Act, S. O. 2006, c. 22, s. 47(6)*. The Legislative Compliance Supervisor is appointed as the Risk Management Official (RMO). The Manager of Compliance and Operational Support or Environmental Compliance Officer(s) are appointed as Risk Management Inspector (RMI) and alternate RMO. The Appointment of Officials By-law is routinely amended to reflect staffing changes.

Certificates of Appointment's were issued to each certified RMO and RMI by the City Clerk, which satisfies subsection 47(7) of the *Act*.

2.2 Required Training (O. Reg. 287/07)

The RMO and RMIs have completed the Ministry of Environment Conservation and Parks (MECP) Source Protection Property Entry and RMO/RMI training courses as per O. Reg. 287/07 under the *Act*. Staff members are responsible to complete the online re-certification training every 5 years.

Two staff members have completed their re-certification training in 2022. The Manager of Compliance and Operational Support and the newly hired Water/Wastewater Environmental Compliance Inspector will complete the training in March 2023 if schedules permit.

3. Risk Management Office in Water/Wastewater Treatment and Compliance

The City of Greater Sudbury passed a Source Water Protection By-law 2015-34 respecting enforcement of the *Clean Water Act, 2006*. All required sections of Part IV of the *Act* are included in the By-law. As per section 55 of the *Act*, a Prescribed Fees Schedule was also incorporated in Schedule A.

A review of the by-law and prescribed fee schedule was completed in 2021 and 2022. The following amendments were recommended to reflect the current process of enforcement and implementation of the *Clean Water Act*. They are as follows:

- updated terms and definitions
- addition of standard legal interpretation and severability/conflict sections
- clarification of the Risk Management Officials delegated authorities as found in the Clean Water
 Act
- increased prescribed fees and planned relocation of fees to the more appropriate Water Wastewater Rates By-law (revised annually)

The proposed amendment will go to Council for review and approval in 2023, after budget deliberations are completed with newly elected Mayor and Council.

3.1 Activity Prohibition (Section 57), Risk Management Plans (Section 59), Restricted Land Use Review of Planning Applications & Building Permits and Risk Assessments (Section 60)

The development status of all Section 57, 58, 59 & 60 processes are considered complete and/or implemented.

3.2 Data and Program Management

The City continues to develop better ways of managing its data. One such improvement includes the development of a web-based Land Management Information System (LMIS). This system is intended to manage Building Permits and Planning Applications received by residents and developers within the City. Part of this process includes the Section 59 Restricted Land Use Review requirement for applications within vulnerable areas. Designated staff will be notified in their email accounts to conduct the review. The LMIS allows users to request additional information from the applicant, select a decision for the review (permitted, permitted with approved RMP, prohibited, not permitted until a RMP has been agreed to), and distribute the completed review package to the appropriate department and applicant.

The business items for each task of the Section 59 Review process were mapped out with the working group throughout 2021. The system was set to begin its training phase spring of 2022 with a final launch in early fall. Unfortunately, many process delays occurred in 2022. The new launch date is set for Q2 2023 for Building Services, with additional permit types and services onboarded throughout the remainder of 2023.

3.3 Section 59 Notices


The Section 59 Restricted Land Use Review process was established internally prior to the effective date of the SPP. Together, Planning and Building Services along with the RMO Office continue to effectively screen a variety of Planning Act applications and Building Permit applications. If criteria are not met for the required Source Protection screening, a memo regarding unrelated projects on properties that may still have existing threat activities is forwarded to the Risk Management Office for information purposes.

The screening of the various applications received by the City result in one of four outcomes:

- Permitted, and a Notice issued,
- Prohibited, and a letter is provided detailing the reason for prohibition,
- Permitted with approved Risk Management Plan (RMP), and a Notice is Issued, or
- Not permitted until a RMP has been agreed to/established, and a letter detailing the requirements is provided.

3.4 Threats Verification

The Risk Management Inspectors conduct threat verification screening inspections in accordance with the *Act*. A total of **51** sites have been identified as having potential threats. This number does not represent additional field visits, background research or other communications encountered.

3.5 Summary of other duties of the City's Risk Management Office

The Risk Management Office, in addition to Part IV responsibilities, guides the various stakeholders at the City in the implementation of all policies for which the City of Greater Sudbury was named the implementing body.


Education and Outreach initiatives continue to be crucial elements to the effective delivery of all Water/Wastewater Treatment and Compliance Services in the community. In partnership with the Environmental Planning Initiatives Section and the Water/Wastewater Task Force, every effort is made to convey Source Protection related information to the public.

4 Part IV Implementation

The following section fulfills the requirements laid out in Section 65 of O. Reg. 287/07. Since the inception of the SPP, 51 files have been opened to investigate the potential requirement for Risk Management Plans. Through the implementation of the program, it has been revealed that not all properties previously identified have required Risk Management Plans.
