**A By-law of the City of Greater Sudbury to Amend By-law 2017-222  
Being a By-law of the City of Greater Sudbury to Establish Miscellaneous  
User Fees for Certain Services Provided by the City of Greater Sudbury**

**Whereas** Section 151 of the *Municipal Act, 2001*, S.O. 2001, Chapter 25, as amended, confers the power to a municipality to pass by-laws to impose fees or charges for services or activities provided, documents provided, use of property and related matters;

**And Whereas** Council of the City of Greater Sudbury did so enact By-law 2017-222 being a By-law of the City of Greater Sudbury to Amend By-law 2017-222, being a By-law of the City of Greater Sudbury to Establish Miscellaneous User Fees for Certain Services Provided by the City of Greater Sudbury;

**And Whereas** Council of the City of Greater Sudbury desires to amend the by-law to correct certain omissions therein;

**Now therefore the Council of the City of Greater Sudbury hereby enacts as follows:**

Repeals


