

By-law 2017-66

**A By-law of the City of Greater Sudbury to Authorize Various Matters
under the Municipal Elections Act, 1996, as Amended,
for the 2018 Municipal Election**

Whereas Section 42(1)(a) of the *Municipal Elections Act, 1996*, S.O. 1996, c.32, as amended, permits the Council of a local municipality to pass by-laws authorizing the use of voting and vote-counting equipment such as voting machines, voting recorders or optical scanning vote tabulators for municipal elections;

And Whereas Section 42(1)(b) of the *Municipal Elections Act, 1996*, S.O. 1996, c.32, as amended, permits the Council of a local municipality to pass by-laws authorizing electors to use an alternative voting method, such as voting by mail or by telephone, that does not require electors to attend at a voting place in order to vote;

And Whereas the Council of the City of Greater Sudbury has determined that it is appropriate to provide for the use of optical scan vote tabulators with respect to the 2018 municipal election and further to provide for alternative voting in the form of internet voting;

And Whereas subsection 9(2) of the *Municipal Elections Act, 1996*, S.O. 1996, c.32, as amended, provides that the Council of a municipality may pass a by-law allowing the use of:

- (a) French, in addition to English, in prescribed forms; and
- (b) French, in notices, forms (other than prescribed forms) and other information provided under the *Municipal Elections Act, 1996*, as amended;

And Whereas Council of the City of Greater Sudbury has determined that it is order to authorize the use of French in the 2018 municipal election;

Now therefore the Council of the City of Greater Sudbury hereby enacts as follows:

Use of Optical Scanning Vote Tabulators

1. The use of optical scanning vote tabulators including any and all associated hardware and software, is hereby authorized with respect to the 2018 municipal election:

- (a) for the positions of Mayor for the City of Greater Sudbury, Councillors for Wards 1 to 12, inclusive, in the City of Greater Sudbury;
- (b) for the positions of District School Board Trustees for the Rainbow District School Board (Public-English), Sudbury Catholic District School Board (Separate-English), Conseil scolaire du district du Grand-Nord de l'Ontario (Public-French)

English), Conseil scolaire du district du Grand Nord de l'Ontario (Public-French) and Conseil scolaire de district catholique du Nouvel-Ontario (Separate-French); and

- (c) for any question or questions which may be put to the electors in accordance with the *Municipal Elections Act, 1996*, S.O. 1996, c.32.

Electronic Voting / Advance Vote / Proxy Voting

2.-(1) The use of electronic voting as an alternative voting method is hereby authorized with respect to the 2018 municipal election:

- (a) for the positions of Mayor for the City of Greater Sudbury, Councillors for Wards 1 to 12, inclusive, in the City of Greater Sudbury;
- (b) for the positions of District School Board Trustees for the Rainbow District School Board (Public-English), Sudbury Catholic District School Board (Separate-English), Conseil scolaire du district du Grand Nord de l'Ontario (Public-French) and Conseil scolaire de district catholique du Nouvel-Ontario (Separate-French); and
- (c) for any question or questions which may be put to the electors in accordance with the *Municipal Elections Act, 1996*, S.O. 1996, c.32.

(2) Section 43 of the *Municipal Elections Act, 1996*, S.O. 1996, c.32, as amended, regarding advance vote shall apply in respect of the 2018 municipal election.

(3) Section 44 of the *Municipal Elections Act, 1996*, S.O. 1996, c.32, as amended, regarding proxy voting shall apply only when an elector attends a physical voting place in order to vote on election day and shall not apply to internet voting authorized under subsection 2(1).

Use of French in all Forms

3.-(1) For the 2018 municipal election all prescribed forms under the *Municipal Elections Act, 1996*, S.O. 1996, c.32, as amended, shall be made available for use in the French language in addition to the English language.

(2) For the 2018 municipal election, all forms, notices and other information (other than the prescribed forms) shall be made available for use in the French language in addition to the English language.


Effective Date
