

**By-law 2015-140**

**A By-law of the City of Greater Sudbury to Amend By-Law 2004-354  
being a By-law of the City of Greater Sudbury Respecting the Licensing,  
Regulating, and Inspecting of Retailers of Second Hand Goods,  
including Pawnbrokers and Salvage Yards**

**Whereas** the Council of the City of Greater Sudbury wishes to amend By-law 2004-354 as amended being a By-law of the City of Greater Sudbury Respecting the Licensing, Regulating, and Inspecting of Retailers of Second Hand Goods, including Pawnbrokers and Salvage Yards;

**Now therefore the Council of the City of Greater Sudbury hereby enacts as follows:**

Amendment to Section 1

1. By-law 2004-354 being a By-law of the City of Greater Sudbury Respecting the Licensing, Regulating, and Inspecting of Retailers of Second Hand Goods, including Pawnbrokers and Salvage Yards, as amended, is hereby further amended by repealing the definition of "Issuer of Licences" in Section 1 and enacting the following definition in its place and stead:

" "Issuer of Licences" means the person appointed from time to time as the Manager of Security, By-law and Corporate Services and, where authority has been delegated under Section 4, includes his or her authorized designates;".

Amendments to Section 4

2. By-law 2004-354 being a By-law of the City of Greater Sudbury Respecting the Licensing, Regulating, and Inspecting of Retailers of Second Hand Goods, including Pawnbrokers and Salvage Yards, as amended, is hereby further amended by adding the following Section 4A after Section 4 and before Section 5:

**"4A.-(1)** The administration and enforcement of this By-law is assigned to the Issuer of Licences who is delegated the authority to:

- (a) make all decisions required of the Issuer of Licences under this By-law;
- (b) perform all administrative functions, conduct all inspections or investigations referred to herein and those incidental to and necessary for the due administration and implementation of this By-law; and

- (c) establish and amend from time to time, such forms and other documents, and such standards, protocols and procedures as the Issuer of Licences may determine are required to implement and administer this By-law.

(2) The Issuer of Licences may delegate the performance of any one or more of his or her functions under this by-law to one more persons from time to time as the occasion requires and may impose conditions upon such delegation and may revoke any such delegation. The Issuer of Licences may continue to exercise any function delegated during the delegation.”.

Amendment to Section 11

- 3. By-law 2004-354 being a By-law of the City of Greater Sudbury Respecting the Licensing, Regulating, and Inspecting of Retailers of Second Hand Goods, including Pawnbrokers and Salvage Yards, as amended, is hereby further amended by repealing Subsection 11.(1) thereof.
- 4. This By-law shall come into full force and effect upon passage.
