

**BY-LAW 2011-242**

**A BY-LAW OF THE CITY OF GREATER SUDBURY TO  
AMEND BY-LAW 2008-180 BEING A BY-LAW OF THE  
CITY OF GREATER SUDBURY FOR THE LICENSING, REGULATING AND  
GOVERNING OF TAXI, LIMOUSINE, AND SHUTTLE TRANSPORTATION  
IN THE CITY OF GREATER SUDBURY**

**WHEREAS** the Council of the City of Greater Sudbury deems it desirable to amend By-law 2008-180, as amended, being a By-law for the Licensing, Regulating and Governing of Taxi, Limousine and Shuttle Transportation in the City of Greater Sudbury;

**NOW THEREFORE THE COUNCIL OF THE CITY OF GREATER SUDBURY  
HEREBY ENACTS AS FOLLOWS:**

Definitions

1. By-law 2008-180 as amended, being a By-law of the City of Greater Sudbury to Licence, Regulate and Govern Taxi, Limousine and Shuttle Transportation, as amended is hereby further amended by adding the following to 2.16A after 2.16 Driver's license and before 2.17 License year.

**"2.16aHearing Committee – defined**

"Hearing Committee" means the Hearing Committee authorized pursuant to the City's Procedure By-law, as amended or replaced from time to time."

2. By-law 2008-180 as amended, being a By-law of the City of Greater Sudbury to Licence, Regulate and Govern Taxi, Limousine and Shuttle Transportation, as amended is hereby further amended by repealing Subsection 6.6 to and including Subsection 6.10, and enacting the following Subsections 6.6 to 6.10 in their place and stead:

**"6.6 Hearing - application - within fourteen days**

An applicant in receipt of a notice pursuant to Section 6.5 may, within fourteen days of receipt of the notice, apply to the Chief Taxi Inspector for a hearing by the Hearing Committee of the City or any other Committee designated by Council.

**6.7 Hearing - time - date - original documentation - Chief Taxi Inspector**

The Chief Taxi Inspector, upon receipt of an application for a hearing, shall give notice of the time and date of the hearing, and shall transmit to the Hearing Committee and the applicant a copy of the original application as completed by the applicant and copies of any supporting documentation filed with the Chief Taxi Inspector.

**6.8 Hearing Committee - procedure**

The hearing shall be conducted before the Hearing Committee or any other Committee designated by Council.

**6.9 Hearing Committee - recommendation - confirmed**


If the Hearing Committee renders a decision recommending that the applicant be granted the license applied for, the license shall be issued upon the recommendation being confirmed by resolution of Council.


**6.10 Hearing Committee - refusal – issue**

If the Hearing Committee renders a decision recommending the refusal to issue the license applied for, no license shall be issued upon the recommendation being confirmed by resolution of Council.”

3. Any applications for hearings to the Planning Committee made before the effective date of this by-law shall be continued by the Hearing Committee.
4. This By-law shall come into force and effect upon passage.
