


**A By-Law of the City of Greater Sudbury to Amend By-law 2015-266

Whereas the Council of the City of Greater Sudbury deems it desirable to amend By-law 2015-266 being a By-Law to Establish Miscellaneous User Fees for Certain Services Provided by the City of Greater Sudbury;


Now therefore the Council of the City of Greater Sudbury hereby enacts as follows:

1. By-law 2015-266, being a By-Law to Establish Miscellaneous User Fees for Certain Services Provided by the City of Greater Sudbury is hereby amended by repealing Schedule "AS-1" and enacting, in its place and stead, Schedule "AS-1" attached hereto as Schedule "A" and forming part of this By-law.
2. This By-law shall come into full force and effect upon passage.
