| <ol> <li>No person shall erect a poster without a permit authorizing that poster sign to be erected.</li> <li>Business or Event Posters expire 14 days after the permit issuance date,</li> <li>Charity Event Posters expire 60 days after the permit issuance,</li> <li>All posters must be removed on the earliest of 48 hours after the permit expiry date or removed 48 hours after the occurrence of the special event advertised on the poster sign.</li> <li>If this condition is not met, the City may: Remove the posters, whereby the posters will be stored for 30 days, and may be redeemed upon payment of:         <ul> <li>a) \$126 or the cost of pulling down and removal, whatever is greater,</li> <li>b) Storage charge of \$10 per day, and</li> <li>c) Signed acknowledgement and release.</li> <li>d) Charges laid under the Sign By-Law 2007-250.</li> </ul> </li> <li>No poster owner shall be granted another permit until all fines have been paid.</li> <li>No poster can be erected on a Non-Designated Pole. Posters can only be attached to Designated Poles set out in Schedule A attached.</li> <li>Posters must not exceed the size of 45.72cm (18") width by 60.96cm (24") in length.</li> <li>No poster can be erected on a designated pole if another poster is already affixed to the pole.</li> <li>Only one poster per designated pole is permitted.</li> <li>No poster can be erected at a height from the ground exceeding 2.14 m (7ft).</li> <li>No poster can be erected using any method other than rope, twine, plastic, or nylon straps.</li> <li>Once permit has been issued with the designated # of poles assigned, the permit is final and cannot be reissued for same event.</li> <li>Business Poster Permits:         <ul> <li>No business poster permit can be issued until 30 days has elapsed from the last permit expiry date.</li> <li>A maximum of 3 business poster permits can be issued in a calendar year.</li></ul></li></ol> |  |                            |                        |            |                             |
