We have reviewed the accompanying Financial Statements – Auditor's Report Form 4 of Miranda Rocca-Cirelli (candidate), which comprises the Statement of campaign Income and Expenses and the Calculation of Surplus or Deficit for the period 05 May 2022 to 07 November 2022 as it pertains to the municipal election held 24 October 2022. The Financial Statements have been prepared by Conroy Accounting from information provided by the candidate based on Section 88 of the Municipal Elections Act, 1996.

Candidate's Responsibility for the Financial Statements

The candidate is responsible for the Financial Statements in accordance with Section 88 of the Municipal Elections Act, 1996 and for such internal control as the candidate determines is necessary to enable the preparation of Financial Statements that are free from material misstatement due to fraud or error.

Auditor's Responsibility

Our responsibility is to express an opinion concerning the Financial Statements based on our review. We conducted our examination in accordance with the Canadian generally accepted accounting principles, requiring that we obtain reasonable assurance that the Financial Statements be free from material misstatement.

The review involves the collection of evidence concerning the amounts and disclosures in the Financial Statements. The selection of procedures is dependent on the reviewers' discretion, including the assessment of risk of material misstatement, whether due to error or fraud. Assessment of risk involves consideration of internal controls relevant to the candidates preparation of financial information that are appropriate to the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the candidate's internal control. The review also includes evaluating the appropriateness of accounting policy used and the reasonableness of any estimates made by the candidate, as well as evaluating the overall presentation of the Financial Statements.

It is our position that the evidence provided constitutes sufficient and appropriate basis for an opinion.

Basis for Qualified Opinion

Due to the nature of the types of transactions involved in an election campaign, the completeness of information concerning donations of goods and/or services and receipts and disbursements is not amenable to satisfactory verification. Accordingly, our verification of said transactions was limited to the documentation provided, and recorded in the statement of the financial institutions supplied by the candidate. We are unable to determine whether adjustments might be necessary to income and expenses, and surplus/deficit.
