#### **BY-LAW 2005-96F**

# A BY-LAW OF THE CITY OF GREATER SUDBURY TO EXEMPT FROM TAXATION PREMISES IN THE CITY OF GREATER SUDBURY USED AND OCCUPIED BY BRANCHES OF THE ROYAL CANADIAN LEGION AND SIMILAR ORGANIZATIONS

WHEREAS Paragraph 325 of the *Municipal Act*, 2001, S.O. 2001, c. 25, authorizes Council to pass a by-law to exempt from taxation, except for local improvements and school purposes, for a period not exceeding ten years, any real property actually used and occupied as a memorial home, clubhouse or athletic grounds by persons who served in the armed forces of His or Her Majesty or an ally of His or Her Majesty in any war;

AND WHEREAS the members of various branches of the Royal Canadian

Legion occupy and use clubhouses for the use of members of the organization and

other persons who served in the armed forces of His or Her Majesty or an ally of His or

Her Majesty in war, upon land in the City of Greater Sudbury;

AND WHEREAS the members of the Navy League of Canada own a property municipally known as 19 Regent Street, Sudbury and occupy a part of the said property as a clubhouse for the use of members of the organization and other persons who served in the armed forces of His or Her Majesty or an ally of His or Her Majesty in war;

AND WHEREAS the members of the Polish Combatants' Association Incorporated No. 24 have erected a clubhouse for use as a clubhouse for the use of members of the organization and other persons who served in the armed forces of His or Her Majesty or an ally of His or Her Majesty in war on property municipally known as 291 Albinson Street, Sudbury;

AND WHEREAS Council has passed By-law 2002-176F granting an exemption from taxation except for local improvement and school purposes for said properties in the City of Greater Sudbury while the properties are used and occupied by a branch of the Royal Canadian Legion, part of the property occupied by The Navy League of Canada and by the Polish Combatant's Association Incorporated No. 24;

AND WHEREAS Council deems it appropriate to pass a By-law under Section 361, establishing a tax rebate program for certain properties in the City of Greater Sudbury while the properties are used and occupied by a branch of the Royal Canadian Legion, part of the property occupied by The Navy League of Canada and by the Polish Combatant's Association Incorporated No. 24 for the year 2005 and thereafter;

## NOW THEREFORE THE COUNCIL OF THE CITY OF GREATER SUDBURY HEREBY ENACTS AS FOLLOWS:

1. In this By-law:

"City" means the City of Greater Sudbury; and

"Similar Organization" means the Royal Canadian Legion, the Navy League of Canada and the Polish Combatants' Association Incorporated No. 24.

- **2.** Each organization noted in paragraph 1 above and included in Schedule "A" of this By-law is deemed to be a similar organization within the meaning of Section 361(4) of the *Municipal Act*, 2001.
- 3. The tax rebate hereby authorized by this By-law will be 100% of the taxes paid by the similar organization in accordance with Section 361 (4) 3 of the *Municipal Act*, 2001.
- 4. The rebate authorized under this By-law shall be shared by the City and the Local School Boards as authorized under Section 361 (7) of the *Municipal Act, 2001*.

- 5. This exemption shall not apply to any premises (or part thereof) other than the premises in the City (or part thereof) identified in Schedule "A", which may be used and occupied by the similar organization identified in Schedule "A" and shall not be transferable or assignable to any other premises which may be occupied by that similar organization in the place and stead of the premises identified in Schedule "A".
- 6. The exemption granted pursuant to this By-law shall cease and no longer apply to the premises in Schedule "A" the day that the similar organization identified in Schedule "A" ceases to use and occupy the said premises identified in Schedule "A".
- 7. By-law 2002-176F is hereby repealed.
- **8.** This By-law shall come into force and take effect immediately upon the passage thereof.
