Executive Summary

Sports has played a major role in the community and social development of the City of Greater Sudbury and its predecessor municipalities. This interest in sport, combined with a willing and dedicated volunteer base and community facilities, has built the City's reputation as a venue of choice for many competitions and tournaments. Major events like the Brier, the Pan American Junior Track and Field Championships, the Canadian Figure Skating Championships, the Canadian Special Olympics, and the Scott Tournament of Hearts have all been successfully held in Sudbury.

Greater Sudbury Sportslink is a community organization dedicated to the betterment of sport in Greater Sudbury. Established in 2003, its mandate includes promoting sport, improving communication and cooperation among sports groups, creating economic development opportunities through sport, providing information on sports funding and training opportunities for coaches, executives and volunteers, ensuring the efficient development, management and utilization of facilities, and recognizing outstanding achievement or contributions to sport.

Recently, members of Sportslink have been actively involved in the Laurentian Track Task Force. Led by Councillor Terry Kett, the task force is making great progress in implementing a short term solution to make the track fully functional in the short term and develop a longer term plan for redevelopment. One of the goals is to restore the track's capacity to host major sports events.

At the last meeting of Sportslink, the opportunity to bid for the 2006 Ontario Paralympics Summer Championships was discussed. Members of Sportslink have vast experience in organizing such events. It was also noted the facilities required are available. Therefore, it was decided that this event would be a good fit for Sportslink and members would act as the Host Organizing Committee. The bid proposal is being prepared by Sportslink members with support from City staff.

The event would be held over 3 days in June or July 2006. The event is expected to attract 500 athletes, coaches, and spectators from outside the city. The direct spending would be in the order of \$300,000. Event costs will be covered by operating grants, registration fees, and community sponsorships. While the City would be responsible for raising all the funds required to successfully host the event, Paralympics Ontario has confirmed that in 30 years of hosting this event, a community has never had a deficit.

We are recommending that City Council support the bid as the host community and provide a contribution of \$5,000 from the existing Tourism Tournament Fund in the current budget.

The Ontario Paralympic Summer Championships is a multi-sport provincial event for athletes with physical disabilities. This annual event determines the best athletes in Ontario, and also provides the opportunity for athletes to progress to national and international levels of competition. At the 2004 Athens Paralympic Games, there were 47 Ontario athletes out of a total of 144 Canadian team members. The Team place 3rd overall winning a total of 72 medals.

Enclosed you will find a copy of the Bid Guidelines for hosting the 2006 Ontario Paralympic Summer Championships. More than 50 communities have experienced the numerous benefits of hosting our Regional and Provincial Championships events, and these benefits include:

- > Increasing the community's sport hosting portfolio.
- > Increasing the accessibility of the community's facilities (sport and other).
- Showcasing the best athletes with a disability in the Province.
- > Develop and train local volunteers, and create a database for future community events.
- > Demonstrate the community's commitment to persons with a disability.
- > Economic impact of hosting.
- Civic pride.
- Creating a legacy for persons with a disability in the community.
- Receive a minimum of two *Ready, Willing, and Able* community outreach sessions leading up to the Championships.

Athletes qualify for the Ontario Paralympic Summer Championships by participating in Invitational and Regional events to be held in the months leading up to the Championships. The 2005 Ontario Paralympic Summer Championships will be held in the Town of Essex, June 24-26, and we invite you to attend this event.

We encourage you to consider hosting this event. Bids are due in the Paralympics Ontario office no later than **Wednesday**, **June 1st**, **2005**, **4:00** pm.

Background:

The City of Greater Sudbury has identified several structures as part of their Capital Roads Program and COMRIF, that require the need for hiring Consultants.

The recommended Consultants are the consultants of record for each structure having completed a condition survey or structural evaluation. It would be prudent to have them continue to develop detail plans, tender documents and provide construction administration services.

The Purchasing By-Law requires Council's approval for sole sourcing of Consultants. The scope of the work varies with each project and costs will be billed at established approved per diem rates. Staff will review the rates prior to assignment of the project to ensure they are acceptable. Total costs are not anticipated to exceed the estimate provided herein.

City staff recommend the sole sourcing of Consultants for the following projects:

- 1) Bridge on Garson Coniston Road (MR 90) at Coniston Creek Northland Engineering (1987) Ltd.
 - This project is funded from the 2005 Capital Roads Program and COMRIF with construction in 2005.
 - Estimate \$65,000
- 2) Bridge on Capreol Skill Hill Road at Vermillion River J.L. Richards and Associates Ltd.
 - This project is funded from the 2005 Capital Roads Program.
 - Estimate \$50,000
- 3) Bridges on Elgin Street at Junction Creek and College Street at Nolin Creek Earth Tech (Canada) Inc.
 - These projects are funded from COMRIF and will be part of 2006 Roads Program.
 - Estimate \$80,000 and \$50,000 respectively
- 4) Bridge on Vermillion Lake Road (MR 13) at MacKenzie Creek Northland Engineering (1987) Ltd.
 - This project will be funded from the 2006 Capital Roads Program.


