

The Northeastern Ontario Recreation Association (NeORA, formerly known as NOMRA, Northern Ontario Municipal Recreation Association) Conference is one of the oldest recreation conferences in Ontario. It began with the first conference in North Bay in 1951. The conference has been held each year since, hosted by communities within Northeastern Ontario.

The Conference Planning Committee consists of City staff, a provincial representative from the Ministry of Culture, Tourism and Recreation, community volunteers, and related partners. The role of City of Greater Sudbury staff will include acting as Chairperson of the Conference Committee and playing a major role in the organizational and administrative functions of the conference. Staff would also be considered the official host to the conference attendees.

Considering the recent presentation to Council on the Healthy Community Strategy, it would be timely and appropriate to focus the theme of the conference on Healthy Communities. The Community Development Department has strong partnerships with agencies such as the Social Planning Council, YMCA, Sudbury and District Health Unit, Laurentian University, Cambrian College, College Boreal, just to name a few. Involving these groups and others would highlight the successes that we as a City, have accomplished and create valuable networking opportunities for our neighbouring towns and cities. The Conference would also provide the opportunity to showcase other successes such as the Volunteer Centre/Benevolat Sudbury, the development of the permanent skatepark in Minnow Lake, and the Trails Masterplan in partnership with Rainbow Routes. Plans are also in place to cover topics on obesity, diversity, intergenerational programming and inclusion, and the Active 2010 project, among others.

The primary purpose of this conference is to provide an opportunity for recreation volunteers, practitioners, elected municipal officials, provincial government personnel, and community partners to meet and network in a professional and organized forum. This approach has cemented a solid partnership for Recreation between Northern Ontario communities and community groups alike. This conference serves to:

- Develop leadership skills
- Increase organizational effectiveness
- Resolve Northeastern Ontario issues in regard to recreation
- Enhance financial management
- Encourage and improve networking between community partners
- Introduce new trends and ideas effecting leisure service delivery
- Advocate and promote the importance of recreation and a healthy community

As the City of Greater Sudbury has become the "hub of the North", so too the City has gained recognition

for leading the North in Parks and Recreation initiatives. Strong alliances have been formed with Parks and Recreation Ontario (PRO), Ontario Recreation Facilities Association (ORFA), Ontario Parks Association (OPA), and the Canadian Parks and Recreation Association (CPRA). There are opportunities to offer certificate programs from these associations during the conference, which creates a substantial draw for attendees across the North.

The NeORA conference has a history of gathering Recreation professionals in one location with the purpose of professional development, increasing awareness in the field of recreation, and promoting a healthy lifestyle in Northern Ontario. The City of Greater Sudbury staff, volunteers, and community partners are prepared to offer the most comprehensive, educational, and motivational forum to date, in September 2006. The NeORA Board of Directors requires a Letter of Support from the Host City as part of the Conference requirements.



To Whom It May Concern

The Copper Cliff Branch of the Royal Canadian Legion is seeking consideration and approval to hold an outdoor event on Saturday the 27th August 2005, 4:00 p.m. to Sunday the 28th August 2005, 2:00 a.m.

The proposed event is to include outdoor entertainment, an open fire, and barbeque. This event is to be held on Legion property at 41 Veteran's Road, Copper Cliff, weather permitting.

The day's events are scheduled in conjunction with the second annual Ride to the Wall hosted by the Southern Cruisers, a local group of motorcycle enthusiasts. The group will be congregating at the Copper Cliff Legion on the morning of the 27th August riding to North Bay for a visit to the Memorial Wall. This year they are also considering a visit to the Sudbury Memorial Wall. On return from North Bay participants again congregate at the Copper Cliff Legion for a barbeque.

Holding this event in 2004, the organization had the hospitality of the Copper Cliff Legion and the North Bay Legion, who conducted a Legion Service at the Memorial Wall and provided hospitality. The Greater Sudbury Police Service and Ontario Provincial Police Provided escorts for the ride from the Copper Cliff Legion to North Bay, again arrangements are being made for these services.

To extend the festivities of this year's event it is proposed that the Legion Branch host an evening of entertainment and a fire fest. In accordance, we seek consideration for such approvals:

Liquor Licence Extension
Noise By-law Exemption
Approval for outdoor fire

As with past outdoor events hosted at the Copper Cliff Legion we will be fencing the front parking lot. Legion members and volunteers will provide security. With past it is reported there has been no incident or concern.

A map is enclosed to indicate the planned layout of the property, the position of the proposed fire on the southwest sector of the property with a direct access to water. The bar and barbeque areas on the east perimeter, barbequed foods will be available throughout the evening. The band will be positioned on the north side of the lot in front of the building.

Should weather conditions or a fire ban hamper aspects of the outdoor activities it is intended that the festivities will be held indoors. Tents will not be erected, however, canopy structures may be used over the bar and barbeque areas as with consideration of the weather.

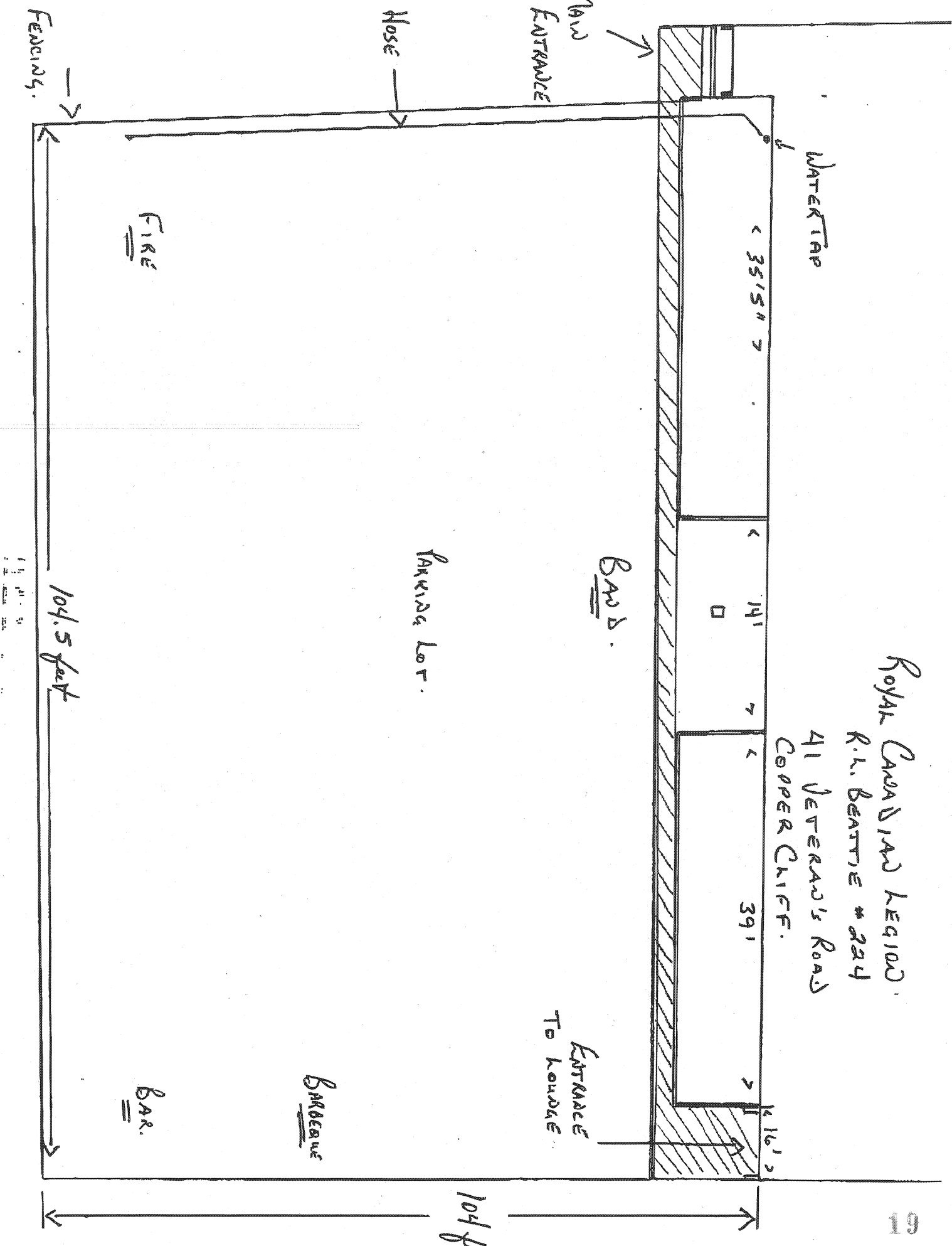

Any money made from this event will be donated to Canadian Diabetis Association.

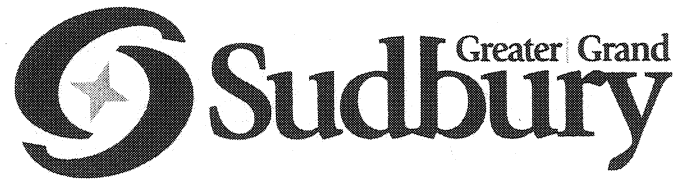
