Social Housing Reform Act

2001-177 Kilgour/Bradley: WHEREAS the *Social Housing Reform Act, 2000* transferred responsibility for social housing administration to municipal control effective January 1, 2001;

AND WHEREAS it is necessary and desirable that the Council of the City of Greater Sudbury adopt a service delivery model for the administration of social housing within the City of Greater Sudbury;

NOW THEREFORE BE IT RESOLVED that the Council of the City of Greater Sudbury hereby adopts the following service delivery model for the governance, administration and implementation of social housing within the City of Greater Sudbury:

- 1. That the Greater Sudbury Housing Corporation (GSHC) be established and that its Board of Directors be comprised of seven (7) persons, four (4) of which, including the Chair, are to be elected Members of Council and three (3) Citizens appointed by Council;
- 2. That the Board of the GSHC report to Council through the Committee of the Whole Planning;
- 3. That a "Housing Services Section", responsible to the Director of Planning Services, be created within the Department of Economic Development and Planning Services, with the mandate to monitor the GSHC, to administer non-profit and co-operative housing providers within the City of Greater Sudbury, including the management of a Common Waiting List, the calculation of Rent-Geared-to Income (RGI), and to provide for ongoing communication and consultation with key community social housing stakeholders;
- 4. That the City of Greater Sudbury provide those administrative services, such as payroll, legal services, et cetera, previously provided by the Ontario Housing Corporation and the Ministry of Municipal Affairs and Housing;

AND FURTHER THAT the Joint Planning Team, consisting of staff and consultants, be directed to utilize this service delivery model as the basis for the development of a proposed Joint Local Transfer Plan to be presented to Council for adoption in May, 2001 and submission to the Minister of Municipal Affairs and Housing for approval, as required by the *Social Housing Reform Act*, 2000.

Transit Centre Contracts
