Terms of Reference (Goals and Objectives)

The Chair stated that the Committee's first priority should be to frame Terms of Reference that set out the rules, goals and objectives, and policies to be followed by the Committee in

order to achieve the mission set by Council.

Terms of Reference (Goals and Objectives) continued:

The Chair briefly elaborated on various points which might be considered by the Committee in framing the Terms of Reference.

The Chair then opened the floor for discussion.

While the Committee generally agreed that the first year of transition for the new City of Greater Sudbury presented unique problems for staff and Councillors, there was a consensus among the Members that an acceptable protocol for reporting the City's financial position in a timely manner to Members of Council did not currently exist and this situation should be corrected as quickly as possible.

There was agreement that Members of Council must know the City's financial position at all times throughout the year. And further, that for the current 2001 financial year, it would be necessary to take quick and proactive measures to ensure a balanced budget by year-end.

The Committee then briefly discussed the current procedure for the preparation of the "capital envelopes". It was the consensus of the Committee that the development of these "capital envelopes" required more Councillor involvement, in that the make up and current decision making process for the selection of capital projects did not reflect the needs and wishes of Members of Council.

Members of the Committee recommended that more "checks and balances" be incorporated into the decisions concerning capital expenditures, operating expenditures and that the process be more transparent to reflect the diverse needs of the community.

The Committee then briefly discussed the Committee's reporting and meeting structure.

Finally, the Committee discussed a reporting framework and time-table for the presentation of variance and financial reports to Council for the year 2001.

Terms of Reference (Goals and Objectives) continued:

At the conclusion of the discussion the Chair summarized the Committee's discussion as follows:

- that the recommendations of the Committee must be substantive and that the City must be honest with the community about any recommended efficiencies;
- in the short term the Committee should recommend spending controls and define the areas of spending in the City's operations where such controls could be put in place;
- in the long term the Committee should define and recommend what and where efficiencies can be implemented and how they are to be monitored;
- Members of Council must have more command of the "capital envelopes";
- a system of "checks and balances" for the financing of capital expenditures and operating expenditures must be put in place; and,
- a clear and timely reporting structure on the state of the City's finances must be established, with more frequent reporting periods towards the end of each fiscal year.

At the conclusion of the Chair's summary, the Committee directed the Chair and Clerk to prepare draft Terms of Reference for consideration at a future meeting of the Committee.

Corporate and Community Reporting

A brief discussion took place on how the Committee would report its findings and recommends to staff, Council and the community. The Committee considered how best to communicate their work through the use of the City's Internet Site. However, there was general agreement that consideration be given to the use of public forums and setting aside opportunities for the public to address Council as part of a regular Council meeting in September of each year.

- 1. Chair Bradley opened the meeting.
- 2 No declarations of conflict were declared.

3. Delegation - Erosion Problem, 1788 Helene Street, Val Caron

Chair Bradley welcomed Councillor Ron Dupuis who made introductory comments in relation to the erosion problem. Mr. Dupuis provided background information on this area and then asked the affected property owner to make comments. A thorough discussion took place. At the conclusion of the discussion, it was agreed that the NDCA would send an engineering consultant out to the site to investigate the causes of the erosion and recommend options to potentially solve the problem. Chair Bradley emphasized that the NDCA has no funding currently to do this type of capital works. However, the information will be shared with the property owner and the NDCA is in a position to provide technical assistance to the property owner should they proceed with corrective works in the future. It was agreed that the site visit will be done as soon as possible in advance of winter conditions.

4. Adoption of Minutes

a) October 10, 2001

Resolution 2001-34

5. General Business

a) Junction Creek Water Management Project - 2002 Work Plan

Information was distributed to members on follow-up discussions with INCO, CN Rail, and Hydro One. Based on that, a final recommendation was presented to members for a 2002 Work Plan. It was emphasized that based on the funding likely available annually, the NDCA will only be able to do portions of projects in any one year. Funding required for the 2002 Work Plan will be included in the budget submission to the City of Greater Sudbury. After a number of questions were answered, the following resolution was passed.

Resolution 2001-35

Courtemanche - Rogers

That the 2002 Work Plan for the Junction Creek Water Management Project be approved as follows:

- a) Completion of Berm #4 construction \$95,000.
- b) Final design; prepare Tender documents; commence construction of Berm #3a 118,000.
- c) Complete site inspection and preliminary design/cost estimate work for Berm #2 7,000.00, for a total planned expenditure of \$220,000,

Subject to final clarification from Inco in relation to the future removal or relocation of berms and seeking alternate reservoir areas.

Carried.

b) i) 2002 Budget Discussions

Preliminary information was distributed to members concerning the NDCA's 2002 budget. Members were advised that a DRAFT budget for 2002 would have to be submitted to the member municipality before the end of November. As well, members were advised that certain new enhanced revenue options contained in the budget will have to be reviewed in detail in the near future as they have a direct relationship to the proposed revenues for 2002. Members discussed the information to be submitted to the member municipality. They agreed with the general levy and capital projects amounts proposed. Based on the municipal budget preparation schedule as it currently exists, members decided that the NDCA 2002 budget could be reviewed and finalized by the February, 2002 meeting.

In preparation for the budget review by members, staff was directed to prepare further documentation dealing with past total budget amounts, levels of provincial grant; levels of municipal levy; status and use of NDCA reserve funds, etc. As well, it was recommended that a multi-year capital projects funding list be prepared to discuss with the member municipality.

ii) Member's Information Session

With the recent appointment of three new members to the General Board, it was decided that it would be helpful to hold an information session to provide them with more detailed information related to Conservation Authorities in general and the NDCA more specifically. It was decided that this session which will also be open to the other NDCA members, will be held on Wednesday, December 12, 2001 in the morning. Staff will be distributing information to members in advance.

c) Watershed Rainfall and Runoff Report

Between September 25th and November 9th, Environment Canada is reporting that the Sudbury area has received close to 15 inches (375 mm) of rain. Although the early fall period typically involves some heavy rains, that amount of rain is at least three times more than normal. These conditions contributed to very heavy runoff conditions and in some cases, caused damage to roads; septic systems; docks/retaining walls, etc. However, the NDCA was not aware of any structures directly affected by overland flood waters. All agencies involved worked together to deal with these conditions. With ground conditions still being fully saturated and water levels still needing to decline further, it is hoped weather conditions will be favourable before freeze-up. The conditions experienced during this period could have an impact on the 2002 spring runoff. Members were satisfied with the ways in which the NDCA reacted to the conditions and in dealing with the general public; media; and other agencies involved.

6. New Business

a) 2002 Meeting Dates

In order for members to be able to plan for meetings of the General Board in 2002, it was recommended that a meeting schedule be adopted now. Members would still have the flexibility to occasionally modify meeting dates, if necessary. After a brief discussion, the following resolution was passed.
