(At its October 24, 2002 meeting, Council approved staff recommendations and directed staff to prepare an Animal Control By-law to come into effect January 1, 2003. Also included in this motion was that a Citizen Advisory Panel be established to oversee the new Animal Control By-law.

On August 12, 2003, Council approved the recommendation that Animal Control Services be outsourced and in doing so concluded the extensive process of finalizing Animal Control Service and Delivery.

Now that the By-law has been implemented and the decision on service delivery has been made, it is now time to establish a Citizen Advisory Panel to review the By-law and oversee service delivery and make recommendations that could improve both the By-law and Service Delivery.)

C-11 Report dated 2003-10-28 from the General Manager of Economic Development & Planning Services regarding Excessive Noise from Local Bar Patios - South End of City.

(At the City Council meeting of October 9, 2003, Councillor Davey submitted a petition to the Deputy City Clerk regarding excessive noise from the outdoor patios at local establishments. This petition was forwarded to Mr. Bryan Gutjahr, Manager of By-law Enforcement Services, for his review.

At the City Council meeting of October 23, 2003, Councillor Davey requested that staff prepare a report regarding the noise stemming from outside patios at local bars.)

(The Ministry of Community, Family and Children Services (MCFCS) advised the City of Greater Sudbury that funding will be available to assist eligible not-for-profit child care proxy agencies with their pay equity obligations as a result of the settlement between the Government of Ontario and five unions. The Government of Ontario has agreed to provide \$240 million of pay equity funding over the next three years (2003-2005) to transfer payment agencies.)

C-13 Report dated 2003-10-21 from the General Manager of Health & Social Services regarding Extreme Cold Weather Alert Mid Term Report. 16 - 18

(On January 24th, 2003 the Council for the City of Greater Sudbury approved two years of funding for the Extreme Cold Weather Alert.

The Extreme Cold Weather Alert is a short-term emergency response to increase available services for people who are especially vulnerable to intensely cold weather conditions. People on the street are encouraged to voluntarily access shelters and services. Individuals who may be at risk due to low temperatures in their homes are also eligible for these services.)

NOW THEREFORE the Mayor and Council hereby directs the Chief Administrative Officer to bring a new employee retirement policy before the new City Council as soon as possible.
