

**BY-LAW 2012-168**

**A BY-LAW OF THE CITY OF GREATER SUDBURY  
TO AMEND BY-LAW 2011-235, BEING THE PROCEDURE BYLAW  
FOR THE CITY OF GREATER SUDBURY**

**WHEREAS** the Council of the City of Greater Sudbury By-Law 2011-235 as amended, established certain procedures for the City of Greater Sudbury;

**AND WHEREAS** Council for the City of Greater Sudbury wishes to amend the said By-law 2011-235 as amended;

**NOW THEREFORE COUNCIL OF THE CITY OF GREATER SUDBURY  
HEREBY ENACTS AS FOLLOWS:**

Amend Article 13 - Public Hearings

1. By-law 2011-235 as amended, being the Procedure By-law for the City of Greater Sudbury is hereby further amended by enacting the following Article 13.05A immediately after Article 13.04 and before Article 13.05:

"13.05A The Chair of a Public Meeting shall encourage speakers to limit their presentations to 5 minutes."

Repeal 16.06 - Local Board Minutes

2. By-law 2011-235 as amended, being the Procedure By-law for the City of Greater Sudbury is hereby further amended by repealing Article 16.06.

Amend Article 28 - Decorum

3. By-law 2011-235 as amended, being the Procedure By-law for the City of Greater Sudbury is hereby further amended by repealing paragraph 28.01(1)(g) and enacting the following in its place and stead:

"28.01(1)(g) display signs, placards or props; or"

Amend Article 38 - Audit Committee

4. By-law 2011-235 as amended, being the Procedure By-law for the City of Greater Sudbury is hereby further amended by enacting the following Article 38.05A immediately after Article 38.04 and before Article 38.05:

**"38.05A Meeting Dates**

The Audit Committee shall usually meet on the third Tuesday of each month, commencing at 4:00 p.m."

Amend Article 39 - Community Services Committee

5. By-law 2011-235 as amended, being the Procedure By-law for the City of Greater Sudbury is hereby further amended by enacting the following Article 39.05A and Article 39.05B immediately after Article 39.04 and before Article 39.05:

**"39.05A Meeting Dates**

The Community Services Committee shall usually meet on the third Monday of each month.

(1) Where there is no meeting of the Operations Committee scheduled on the same day, the Community Services Committee shall meet at 4:00 p.m.; and

(2) Where there is a meeting of the Operations Committee scheduled on the same day, the Community Services Committee shall meet either thirty minutes after the Operations Committee adjourns or at 6:00 p.m. whichever is earlier.

Amend Article 41 - Operations Committee

6. By-law 2011-235 as amended, being the Procedure By-law for the City of Greater Sudbury is hereby further amended by enacting the following Article 41.05A immediately after Article 41.04 and before Article 41.05:

**"41.05A Meeting Dates**

The Operations Committee shall usually meet on the third Monday of each month, commencing at 4:00 p.m."

Amend Article 42.06, Automatic Adjournment, Planning Committee

7. By-law 2011-235 as amended, being the Procedure By-law for the City of Greater Sudbury is hereby further amended by repealing Article 42.06 and enacting the following Article 42.06 in its place and stead:

**"42.06 Automatic Adjournment**

The Planning Committee meeting shall automatically adjourn at 10:00 p.m., or after 4.5 hours, whichever is earlier, unless directed to continue by unanimous consent of the Members present, and unanimous consent shall be required hourly thereafter."

Effective

8. This By-Law shall come into force and take effect immediately upon the passing thereof.
