### Terms and Conditions

I am requesting permission to install a security system on the above property. I understand and agree to the following conditions:

- I agree that installation will not begin until permission is granted, in writing by the GSHC.
- I understand that the GSHC has the sole right and absolute discretion to determine an acceptable location for the security system and may or may not grant permission for that installation to proceed.
- I understand and agree that due to privacy regulations, GSHC can only permit camera installations that capture the tenant's yard only. Cameras cannot record a neighbour's yard or any common areas.
- I agree that the security system will be professionally installed, with non-staining fasteners adequately sized and of an appropriate type for the surface that the security camera will be anchored.
- I agree that the installation cost of the security system is the sole responsibility of the tenant.

- I understand and agree that in the event of an emergency, Housing Operations staff will not key in a security code or call before entry.
- I understand and agree that GSHC will not be responsible for any cost associated with a security response or repairs to the system if security or police respond due to Housing Operations staff entering the unit for an emergency, or on a 24 hour notice.
- I agree that the resident is responsible for ongoing maintenance and inspection of the security system.
- I understand and acknowledge that the GSHC may require that the security system be temporarily removed to permit construction or routine maintenance work to take place.
- I understand that this security system policy is subject to change without further notice, and that the Greater Sudbury Housing Corporation reserves the right to alter this policy as they see fit.
- I understand that the system will be removed, on move out, at the resident's expense.
