



# Non-Residential Waste Collection Yellow Cart Organics Program

## Application Form

The Yellow Cart Organics Program is available to non-residential units (hair salon, church, small store, etc.) for an annual service fee of \$123 (adjusted yearly according to a cost index). The program provides weekly curbside organics collection similar to the residential green cart organics collection program.

**The establishment must be located on a residential organics collection route.**

**The program is limited to a maximum of three (3) yellow carts.**

Material placed in the Yellow Carts must be contained in a tied certified compostable bag or compostable paper bag. Look for one of these symbols when purchasing bags.



- i) If you're interested in the program, please complete the attached Yellow Cart Organics Program application form.
- ii) The form will be reviewed to determine if the establishment is located on a residential collection route.
  - a) If approved, the applicant will be notified and must sign the terms of service which must be submitted along with the non-refundable annual fee and payment for the container(s). Upon receiving the payment, the City will provide the establishment the container(s) at the Environmental Services Division office located at 1805 Frobisher Street in Sudbury.
  - b) If the application is not approved, the applicant will be notified and provided with any applicable alternatives.
