## Yellow Bag Program for Licensed Home Child Care Providers

### Application Form

The Yellow Bag Program for Licensed Home Child Care Providers is available to establishments who do not produce more than two (2) bags of diaper waste every week. The program provides licensed home child care providers with weekly roadside collection of diaper waste.

**The establishment must be located on a residential garbage collection route to qualify for the program.**

**The program is limited to two (2) yellow bags (with the City logo) every week, on your scheduled collection day.**

If approved, bags will be distributed by Jubilee Heritage Family Resources. The establishments must notify the Environmental Services office upon program cancellation. Registered participants who cease to be licensed or provide child care services altogether will be removed from the collection routing system and the collection of Yellow Bags will be discontinued. Any unused Yellow Bags must be returned to Jubilee.

This program is for diaper waste only. No other waste shall be placed in the yellow bags and the bags must not exceed 18 kg (40 lbs) in weight.

- i) If you're interested in the program, please complete the Yellow Bag Program for Licensed Home Child Care Providers application form.
- ii) The form will be reviewed to determine if the establishment is located on a residential collection route.
  - a) If approved, the applicant will be notified and can obtain their Yellow Bags from Jubilee.
  - b) If not approved, the applicant will be notified and encouraged to contact private garbage collection companies or to deliver garbage directly to the landfill and or to the Walden small vehicle transfer site.
