

Non-Residential Waste Collection Yellow Bag Garbage Program

Application Form

The Yellow Bag Garbage Program is available to non-residential units (hair salon, church, small store, daycares, etc.) who do not produce more than 6 bags of garbage every other week. The program provides non-residential units with roadside garbage collection every other week, similar to the residential program.

The establishment must be located on a residential garbage collection route to qualify for the program.

The program is limited to six (6) yellow bags (with the City logo) every other week, on your scheduled collection day.

Bags are sold in packages of 10 for \$35. Approved applicants must pay a \$100 refundable deposit to join the program. Deposits are refunded upon program cancellation.

 i) If you're interested in the program, please complete the Yellow Bag Garbage Program application form.

- ii) The form will be reviewed to determine if the establishment is located on a residential collection route.
 - a) If approved, the applicant will be notified and must sign the terms of service which must be submitted along with the refundable deposit.
 Upon receiving the signed terms and deposit, the establishment may purchase Yellow Bags at the Environmental Services Division office located at 1805 Frobisher Street in Sudbury.
 - b) If not approved, the applicant will be notified and encouraged to contact private garbage collection companies or to deliver garbage directly to the landfill and or to the Walden small vehicle transfer site.
