Rebate for Dog Waste Digester

Application Form

This rebate is available to eligible residents of the City of Greater Sudbury to help offset the cost of a dog waste digester.

A one-time rebate of up to \$50 is available per household.

The rebates are processed on a first come, first served basis.

Your residence must be eligible to participate in the City's curbside collection program in order to be considered for this rebate.

Your dog must be registered/licensed with the City of Greater Sudbury.

Receipts predating 2016 will not be considered.

Allow at least 8 weeks for your application to be processed.

Please note that you may only apply for this rebate one time, per household.
