

# Special Support Program Garbage Container Limit Exemption for Pet Waste

# **Application Form**

This application is for Greater Sudbury households which may need to set out more than the approved garbage bag/ container/bundle limit due to cat or dog pet waste.

You may qualify for an exemption for your pet if you currently receive and are eligible for residential roadside garbage collection services from the City of Greater Sudbury.

You must also participate in the City's waste diversion and recycling programs as detailed below.

If the application is approved, all your garbage must be set out in clear bags, with the allowance of one small (grocery bag size) opaque privacy bag inside each clear bag of garbage. The exemption will allow for one clear bag, in addition to the approved garbage bag/container/ bundle limit. Residents not wishing to participate in this program could purchase garbage bag tags, flush their pet feces in the toilet, apply for a rebate to purchase a dog waste digester, consider hiring a company to remove the pet waste or deliver the extra waste directly to the landfill site.

You will be contacted at the email address or phone number provided on the form when the application is approved, denied or more information is required.

# Your application must be approved prior to placing additional clear bags with pet waste at the curb for collection.

Allow at least 2 weeks for your application to be processed.

Please note this application must be renewed annually on the service anniversary date for continued service. The exemption will end if you do not renew your application.

\*The Pet Tag Registration Number is the number provided on the Pet Tag Registration receipt and on the tag that you receive when you register/license your pet with the City of Greater Sudbury.

### TERMS AND CONDITIONS (Check square icons to agree)

- I have a registered cat/dog permanently residing at a household at the address listed above.
- I agree that all my garbage will need to be placed in clear bags, with the allowance of one small opaque privacy bag inside each clear bag of garbage.
- I agree that the pet feces will not exceed 10 percent of the total amount of waste in my clear bag and that the bags will not exceed 18 kg (40 lbs) in weight.
- I also acknowledge that participation in Greater Sudbury's Blue Box Recycling, Green Cart Organic and the Leaf & Yard Trimmings Collection programs is required for this exemption and I agree to fully participate in these programs if allotted a bag limit increase. I understand that the exemption will be terminated if I do not participate in these programs.



### TERMS AND CONDITIONS (continued)

- I consent to the disclosure of the fact that my household qualifies for the pet waste exemption to the City of Greater Sudbury and third party waste collection crews.
- O I acknowledge that the City may require proof of my pet's registration to prove eligibility for this program.
- I agree to notify the City if I no longer require the exemption, if I move, or if I am no longer in possession of the cat/dog.
- I acknowledge that my exemption will be terminated if I do not meet the requirements of the program or if I fail to comply with program requirements.
- I acknowledge that the program will expire in a year and that I must reapply for the service at least two weeks prior to the exemption end date. I understand that I will not be provided a reminder.
- Please Note: Information on the City's waste diversion and recycling programs is available on our website at www. greatersudbury.ca/wastemanagement, on our Waste Wise Greater Sudbury app or can be provided upon request by calling City Services at 3-1-1.
  - The only information provided to collection crews will be your address, the number of exemption bags permitted and the date when the exemption will expire.
  - If necessary, please report any service issues to City Services at 3-1-1.
