



Dear Non-Profit or Charitable Organization:

Re: Biz Box Recycling Program

The ‘Biz Box’ Recycling Program is available to approved Non-Profit or Charitable Organizations at no charge. The program provides organizations that generate small quantities of recyclable materials with a weekly curbside recycling collection similar to the residential blue box collection program. **The organization must be located on a residential recycling collection route.**

The program is limited to three (3) yellow boxes or one (1) big yellow with a lid. Organizations that generate large quantities of recyclable materials must contact a private recycling company for collection services.

If you’re interested in the program, please complete the attached “Biz Box” application form and fax it to 705-671-1148 or e-mail it to wastemanagement@greatersudbury.ca.

The form will be reviewed to determine if the organization is located on a residential collection route. If approved, the organization will be notified and must sign a terms of service agreement. The initial collection containers will be provided at no charge and must be collected from the Environmental Services Division office located at 1805 Frobisher Street in Sudbury.

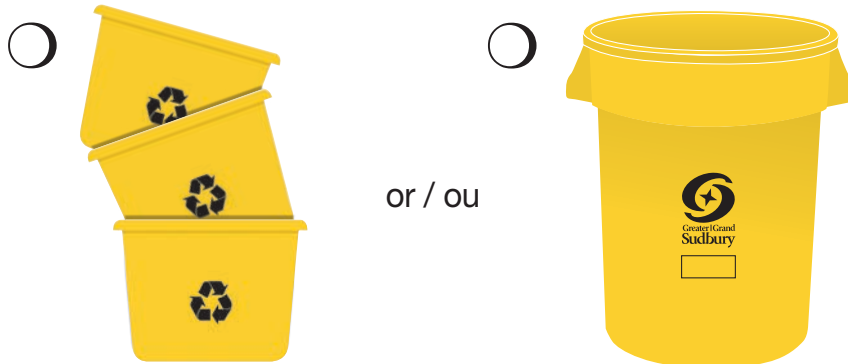
