

# Construction NOTICE



## Kingsway, (Sudbury) Road Rehabilitation and Active Transportation Improvements

The City of Greater Sudbury will be completing **road and water improvements** on the **Kingsway, (Sudbury)**, between Silver Hills Drive to Falconbridge Road.

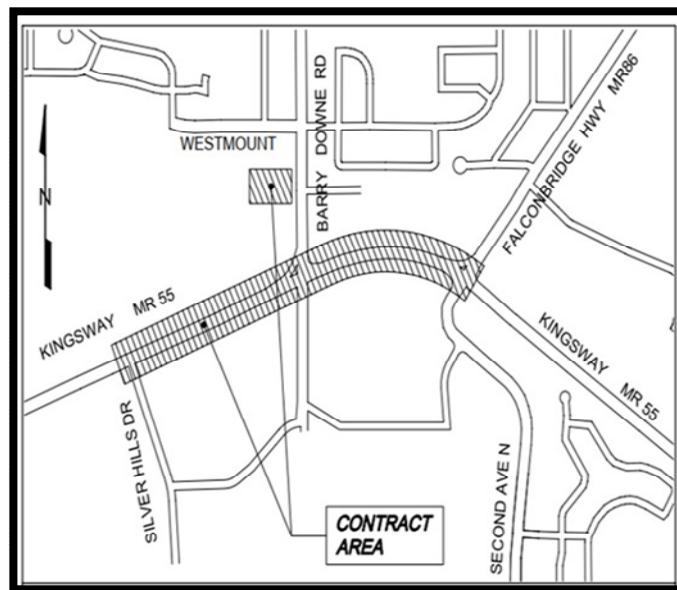
**Construction by the City's contractor, Interpaving Limited** will be carried out between **September 2022 and October 2024**.

**Work** will take place **Monday to Friday, 7 a.m. to 7 p.m. (subject to change)**.

Please note these timelines are subject to change.

### Construction Details:

- Cycle infrastructure upgrades (Introduction of "off road" cycle tracks)
- Asphalt paving
- Urbanization of Kingsway between Barry Downe Road and Falconbridge Road (new concrete sidewalk and curb on both sides of the roadway)
- Watermain improvements
- Storm sewer improvements
- Lighting upgrades
- Traffic signal replacement
- Utility relocations
- AODA upgrades



- Phase 1 – Silver Hills Drive to Barry Downe Road 2022 (surface asphalt to be placed in 2023).
- Phase 2 – Barry Downe Road to Falconbridge Road 2023 (surface asphalt to be placed in 2024).

**Note:** Phasing above supersedes phasing stipulated on Pre-Construction Notice.

During construction, there may be dust and noise in the area. The City makes every effort to reduce the impact to nearby residents and business owners. 	<p><b>Before Construction Begins:</b></p> <ul style="list-style-type: none"><li>Property owners should remove items located within the municipal right-of-way, such as landscaping, fencing, sprinkler systems and decorative objects.</li><li>Property owners should redirect to above ground, any roof drains and /or sump pump outlets that currently discharge into the front ditch.</li><li><b>The City is not responsible for damage to any privately-owned items on the municipal right-of-way.</b></li></ul>
	<p><b>Possible Water Service Disruptions:</b></p> <p>On occasion, during construction, the water supply to your property may need to be shut off. The contractor will provide at least 24-hours notice. If you do not receive advance notice of a water disruption, this may mean an emergency shut-off was necessary. It is recommended that you disconnect any water treatment systems, such as water softeners or filters, during scheduled water service disruptions.</p>
	<p><b>Temporary Water Service Supply:</b></p> <ul style="list-style-type: none"><li>Homes in the construction area may be connected to a temporary water supply system. You will continue to receive municipal water service while work is underway.</li><li>If required, the temporary system connects your outdoor water faucet to a hose that is specially designed for potable drinking water. It's very important not to disconnect or turn off your outdoor faucet while this temporary water supply system is in place. Your water consumption will not be metered while receiving water from the temporary supply system. Instead, your bill will be based on a monthly average.</li><li>Please note that the City's contractor, <b>Interpaving Limited</b>, may need to access your property or residence to connect this temporary water supply system. If you are not home, a business card will be left at your residence. Please call the number to arrange an appointment.</li><li>If temporary water service is required, you can expect two brief water service interruptions: one to connect the temporary water supply system, and a second to connect the new watermain once the work is complete. You will be notified in advance of any water service interruptions.</li></ul>
	<p><b>Traffic:</b></p> <p>Plans are in place to manage traffic in the area to ensure the safety of workers and residents. You may experience some delays and increased traffic on nearby main and side streets.</p> <p><b>The work identified for the Kingsway will reduce lanes of traffic.</b> Your patience is appreciated.</p>
	<p><b>Driveway Access:</b></p> <p>If temporary driveway closures are required, the contractor will provide notice to the affected properties and make arrangements for alternative access and parking when necessary. <b>Entrances to businesses and public institutions shall remain accessible at all times.</b></p>
	<p><b>Road and Sidewalk Access:</b></p> <p>Safe access for pedestrians will be maintained. Parents are reminded to teach children about road safety in active construction zone areas. Residents who have accessibility needs, such as wheelchair access, are asked to contact the City Field Inspector or Project Manager listed on this notice.</p>
	<p><b>Inspections:</b></p> <p><b>Interpaving Limited</b> will complete a review of structure and building conditions prior to the beginning of construction. These inspections will only be performed with permission from the property owner.</p>
	<p><b>Blasting (if required):</b></p> <p><b>During Construction:</b></p> <p>If rock is encountered during the course of Construction blasting may be required. During blasting operations, you can expect to feel some vibration and hear some noise. The sound following the blast is a shock wave or air concussion, which is harmless. Vibration levels are monitored during the blasting operations by the consultant to ensure levels are within allowable ranges.</p> <p><b>After Construction:</b></p> <p>Once the work is complete, upon request to the Contractor, the post-blast survey of your home can be made available to you.</p>
	<p><b>Emergency Services and Public Transit:</b></p> <p>Access for police, fire and paramedic services vehicles will be maintained at all times.</p> <p>Public transit detours may occur during construction. Please call GOVA at 705-675-3333 or visit <a href="http://www.greatersudbury.ca/gova/">www.greatersudbury.ca/gova/</a> for information. Should the work affect the school bus route, the Sudbury Student Services Consortium will inform you of any changes to the scheduled route.</p>
	<p><b>Garbage Collection:</b></p> <p>Garbage, recycling, and leaf and yard trimmings pickup will not be affected by construction. Please place your waste at the front of your property before 7 a.m. on your regular collection day. If waste collection vehicles are unable to access properties in the construction area, the contractor will transport the waste outside of the zone for pickup. Your garbage, recycling and organics containers will be returned to your property later in the day. <b>Please ensure your containers are labeled with your address so that they can be returned to you.</b></p>
	<p><b>Mail Delivery:</b></p> <p>Should the work affect mail delivery to your home, Canada Post will inform you of any changes to the scheduled route or provide you a location you can pick up your mail.</p>
