Details of Proposed Construction

Struthers Street, Sudbury – Road Reconstruction

The City of Greater Sudbury will be completing road and water/wastewater improvements on **Struthers Street, Sudbury, between Junction Creek and Regent Street.**

Project Highlights:

- Realignment of the 5-way intersection.
- Reconstruction of the roadway including new granular and asphalt.
- Installation of new concrete curb and sidewalk.
- Installation of a new watermain including services.
- Installation of a new sanitary sewer main including services.
- Installation of a new storm sewer system within roadway.
- Reconstruction of a portion of the connecting side streets including full depth asphalt removal and replacement of concrete curb, sidewalk, and asphalt.

Expected Start Date: Spring 2023
Expected End Date: Summer 2024

Winter shutdown between November 2023 and April 2024.

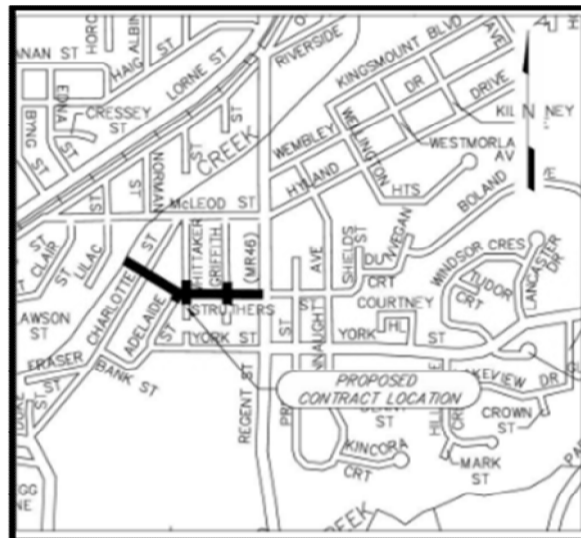

Before Construction Begins:

- Work crews will mark the locations of underground utilities, such as gas, water and cable so that the construction work does not interfere with these utilities.
- Soils Investigation to determine sub-soil surface conditions. This work is expected to take place prior to Construction.
- Once a Contractor has been selected, affected property owners will receive a construction notice with more information about the work.
- Property owners should redirect to above ground, any roof drains and/or sump pump outlets that currently discharge into the front ditch.
- **The City is not responsible for damage to any privately-owned items on the municipal right-of-way.** Property owners should remove items located within the municipal right-of-way, such as landscaping, fencing, sprinkler systems and decorative objects.
- Once Struthers Street and connecting side streets have been repaved with new asphalt, roadway cuts to install new utilities will not be permitted for a period of three years. Therefore, you should contact your hydro, gas, telephone or cable providers should you require changes to these services as well as notify the Project Manager below.
- Should you wish to make any modifications to your property entrance or replace an existing culvert, please contact the Project Manager listed below prior to **April 28, 2023.**
- We have also camera inspected your sanitary sewer service and plan to replace your service from the sewer main to lot line.
