#### Background

Attached is the annual Treasurer's Statement of Remuneration and Council Expenses for the period January 1, 2019 to December 31, 2019 for the City of Greater Sudbury Mayor, Councillors and council appointees for Council, committees, panels and other entities.

Payments to the City of Greater Sudbury members of Council were made under the authority of Remuneration to Members of Council and Local Boards By-law 2018-145 and amended by By-law 2019-154 and the Payment of Expenses for Members of Council and Municipal Employees By-law 2016-16F which were passed pursuant to Section 283 of the Municipal Act. In accordance with the City's by-law on Transparency and Accountability, the City of Greater Sudbury discloses an itemized statement of Council expenses on a quarterly and annual basis.

Payments made to City of Greater Sudbury Council appointed members to other entities were paid pursuant to Section 283 of the Municipal Act and reported to the Treasurer as required under Section 284(3) of the Municipal Act.

The annual Treasurer's Statement of Council Expenses discloses the total transactions by member of Council. The appendices disclose the details of each transaction including payee, date paid, amount, general description and name of benefitting organization if applicable.

In 2017, as part of the federal budget, mandated changes were made to the portion of a Councillor's earnings that was taxable. The changes are effective for the 2019 taxation year and are outlined in a report to the Finance and Administration Committee of February 6, 2018.

The City is required to comply with this legislation. Prior to the changes and under the guidelines by Canada Revenue Agency, members of Council had one third of their earnings deemed tax exempt. This meant fewer taxes were being deducted. The City was also able to claim an HST rebate on the amount exempt, which resulted in less cost to the City.

As a result of these changes in legislation, the City was required to increase the Members of Council remuneration to ensure that they are effectively compensated at the same rate as provided for in the By-Law, effective January 1, 2019.

At the time of the announcement, it was anticipated the changes would result in an increase to the 2019 budget in the amount of \$188,000. The actual increase to the budget was \$190,382.

The numbers outlined in the attached report reflect an increase in remuneration for members of Council to ensure everyone received the same net pay to balance the change to the taxable portion of earnings. The change also resulted in an increase in fringe benefits.
